The fireworks within Tides West during the Fourth of July holiday were discussed. The Board will impose fines next year if eyewitnesses can provide names and addresses.

## OLD BUSINESS

### Property Conditions:

The Department of Public Works will begin drainage work in the park after the Annual Meeting in August.

Joe Cryblskey, 19402 – 19412 Pacific Way, will be notified that a fine will begin as of September 1, 2017, if his disabled RV is not removed.

Leonard Moen, 1216 194<sup>th</sup> Street, will be asked to remove his shredded flag.

The Board received a letter from William Sidel, 1109 194<sup>th</sup> Street, asking that trees blocking ocean views be trimmed. A tree and rhododendron on the Tides West beach path also require attention. The property owners in question will be contacted.

The Loomis Lake Restoration Group met May 31, 2017, with representatives of the Pacific Conservation District, State, and Pacific County officials at the Ocean Park Fire Station. An overview was presented by Mike Nordin and discussions were held about future projects.

The Loomis Lake Special Projects Groups met July 13, 2017, to review the latest progress of the restoration of Loomis Lake. Weed monitoring continues, discussions were held about a website and communication documents, and the potential restoration of the public landing. The next lake treatment will be the week of July 24 -27.
